The contents of the HIP field

Name of the HIP field: Civil Law

The contents of the HIP field: The field of **Civil Law** comprises knowledge, procedures and research methods focused on the issues of civil law.

The basic premise of civil law, or of private law, is private autonomy and the means of its implementation and protection. Its focus is on research of legislation with specifically protected goods and with special means of legal regulation. The primary subject of research are the issues of regulation, operation and effectiveness of private law legal standards, their relationship to private autonomy, or private law rules as motivating factors and their effectiveness.

The content of the field also incorporates examination of basic legal institutes of substantive and procedural civil law and selected aspects of specific areas of private law regulation (private law relations with a foreign element but also special forms of private law of legal entities, such as commercial companies).

Attention is paid to the theoretical underpinnings of individual civil law legal institutes, their systematic anchoring and their mutual links, the application of legal standards, but also basic research into methodological issues related to creation, interpretation or application of legal standards in the field of civil law.

The historical and comparative dimension of the study of civil law, including basic methodological research, is also being developed in this field. As part of the process of habilitation and inauguration proceedings, the applicant shall demonstrate teaching abilities and skills as well as competencies in relation to these scientific research and creative activities.

Definition of the HIP field

The content of the field to which the habilitation and inaugural proceedings pertain is in line with the focus of the academic program of Law, to which it is assigned.

The content of the field is defined in such a way that it corresponds to the supporting topics of the core knowledge of the academic program of Law. The main content elements of the field to which habilitation and inaugural proceedings pertain are primarily:

- The issues of private law regulation, the operation and effectiveness of private law legal standards, their relationship to private autonomy, private law rules as motivating factors and their effectiveness;
- The scope and the limits of private autonomy;
- The issues of legal personality (entity), entities under law, constitutional and functional elements of legal entities, their organizational structure, including commercial companies;
- Contractual and non-contractual obligations, both of civil and commercial legal nature;
- The issues of substantive rights and other absolute rights;
- Private law aspects of family relations;
- Procedural legal aspects of private law relations implementation;
- A comparative approach to research in the field of civil law, manifested both in relation to research; methodological approaches to private law institutes as well as to individual legal institutes of private law;
- Historical perception of individual legal institutes of private law; and
- The impact of transnational and international rules on private law.
