

# **MEMORANDUM OF UNDERSTANDING**

In accordance with the goal to promote further cooperation between the Faculty of Law, the University of Trnava in Trnava and the Bytom University of Economics and Administration, Bytom, Polska both parties to the Memorandum (hereinafter only "Parties") join in the following agreement on development, educational and research cooperation.

Cooperation in specific areas may be designated by mutual consent and incorporated as addenda to this agreement upon signature by appropriate representatives of Parties. The details of cooperation for any of the identified fields may also be specified in the form of addenda to this agreement upon signature by appropriate representatives of Parties.

## **Article 1**

Within the fields of activities to the mutually designated, Parties agree to the following general forms of cooperation:

1. Common educational and training activities based on the existing programs managed by parties mostly but not exclusively in the area of self – government and public administration and law;
2. Mobility of students and teachers;
3. Participation on conferences, seminars and other academic and research activities;
4. Development of joint distance learning curricula and technological support;
5. Joint research activities based on the existing activities;
6. Joint participation in fund raising and project development to support the activities listed above.

### **Article 2**

1. Parties agree that all financial arrangements necessary to implement this agreement must be negotiated and will depend upon the availability of funds.
2. This Memorandum shall enter into force on the date of its signature by the representatives of Parties and upon the approval given by appropriate authorities in their respective countries.
3. The present Memorandum is concluded for a period of four years. Its validity shall be extended, always for another four - years period, unless one of Parties denounces it in writing at least three month before the given validity period expires.
4. Each Party shall have the right to terminate the Memorandum upon three - months' written notice to the other Party at any time or as may otherwise be agreed. If the Memorandum of Understanding is terminated by either Party, steps shall be taken to ensure that the termination does not affect any prior obligation, project or activity already in progress.
5. The Memorandum of Understanding may be modified or amended by written agreement between Parties.
6. This Memorandum of Understanding has been drawn up in English, in six originals, three for each of Parties.
